By virtue of the authority vested in me by the constitution and laws of the State of Louisiana, I will sell by public auction at the Grant Parish Civic Center located at 1208-2 Main Street, Colfax, Louisiana 71417 beginning at 11:00 a.m. on the 20<sup>th</sup> day of May 2026, and continuing on each succeeding legal day, until the auction is complete, the tax lien I will issue in favor of the winning bidder and record in the Mortgage Records a tax lien certificate to all immovable property on which taxes are now due to the Grant Parish Sheriff and Tax Collector, to enforce collection of ad valorem taxes of the Grant Parish Tax Collector assessed in the year 2025, together with interest thereon beginning January 1, 2026, at the rate of one (1%) percent per month on a noncompounding basis until paid.
