

IMPORTANT INSTRUCTIONS TO DEFENDANT

Pursuant to a court order, you must transfer any firearm(s) or concealed handgun permit to the Grant Parish Sheriff's Office. If you do not possess firearms or a concealed handgun permit, you are still required to complete a Declaration of Non-Possession.

FOLLOW THESE INSTRUCTIONS:

DO NOT BRING FIREARMS INTO SHERIFF'S OFFICE BUILDINGS

1. Immediately contact the Grant Parish Sheriff's Office to initiate the "Proof of Transfer or Declaration of Non-Possession," at (318) 627-2006. Inform the deputy that the Court has ordered you to transfer your firearm(s) to the Grant Parish Sheriff's Office and that you are requesting an appointment and the assigned deputy will contact you. You must disclose the number of firearms involved in the transfer. Please have your docket number available. This number is printed on your Court order.
2. **IF YOU DO NOT** possess a/any firearm(s) or a concealed handgun permit, and you have not already done so in Court, you are ordered to report to the Detectives Division located at 100 8th Street, Colfax, LA 71417, during normal business hours, **Monday-Friday (8:00am-4:00pm)** to execute your Declaration of Non-Possession. The Grant Parish Sheriff's Office will provide this form to you. Be advised that you must have a copy of your court order and proof of identification.

*****AGAIN, DO NOT BRING YOUR FIREARMS WITH YOU INTO THE OFFICE*****

3. Once you are contacted by a deputy to schedule your transfer you must be prepared to choose from the following transfer options:
 - a. Third party transfer. The receiving third party must not reside in the same home with you and cannot be a prohibited possessor. The Third Party Transfer form is available on the Grant Parish Sheriff's Office website, www.grantso.org/firearmstransfer. – Possible Fee. The Grant Parish Sheriff's Office does not charge a fee to store firearms transferred.
 - b. Transfer to the Grant Parish Sheriff's Office for safekeeping. – No Fee
 - c. Legal sale or donation with written proof of transaction. – Fee Applies
 - d. Storage at a Grant Parish Sheriff's Office approved facility. – Fee Applies

If a third party transfer option is chosen pursuant to state law, a Third Party Transfer and Acknowledgement form must be completed and provided to Grant Parish Sheriff's Office. This form notifies the third party of the relevant state and federal laws and consequences for noncompliance.

4. If you choose to transfer your firearm(s) to the Grant Parish Sheriff's Office, follow the procedures listed below:
 - a. Call 318-627-2006 to arrange the transfer. The deputy will provide a location to you for the transfer.
 - b. If possible, arrive alone at the designated location. Firearm(s) are to be **UNLOADED** and locked inside your vehicle (trunk if possible).
 - c. Everyone must exit the vehicle with you and you must have your court order, proof of identification and keys.
 - d. You are to remain outside the vehicle, until otherwise informed by the Deputy.
 - e. **DO NOT RE-ENTER THE VEHICLE UNTIL INSTRUCTED TO DO SO.**
 - f. Upon completion of the transfer, you will receive a "Proof of Transfer" form and if required, a receipt from the Deputy. This form is required so that you can show proof to the Court that you have complied with the transfer order.
 - g. **YOU** are required to file the Proof of Transfer Form with the issuing Clerk of Court within five days of the transfer (exclusive of legal holidays only).

YOU ARE RESPONSIBLE FOR COMPLYING WITH THE CONDITIONS OF THE COURT ORDER WITHIN FORTY-EIGHT (48) HOURS OF ITS ISSUANCE.
